Key Features

- **Number type classification and CAC settings:**
 - ✓ Contact center numbers can now be added to UC platforms such as Zoom, Webex, and any other UC platform that supports them.
 - ✓ Each number is now classified as one of the following types (except Live CX where all numbers are classified as contact center numbers):
 - User Numbers – regular DIDs assigned to individual users
 - Service Numbers –for IVR, Call Queues/Auto Attendants, or PBX services
 - Contact Center Numbers – support for optional session-based metering, like the Live CX service

Action Required: Update your number types within two months of this release. Any UC numbers that remain undefined after this deadline will automatically be classified as User-type numbers in the next release.

- **Editable SIP connections:** Existing SIP connections can now be updated directly from the interface, enabling quicker and more flexible configuration changes. Supported updates include Customer Variables, Carrier Registration, and CAC Profiles.
- **New BYOC capabilities:** Expanded support for self-managed custom changes in SIP connections, with the ability to apply updates to these values at any time.
